



## **SAWStudio Good Faith Agreement**

I understand that Robert Lentini of RML Labs, proprietary owner and developer of the SAWStudio software, is hereby offering this agreement, in Good Faith, to me and/or my organization, for the purpose of purchasing the SAWStudio or SAWStudioLite software.

Upon submission of this signed Good Faith Agreement and my first month's payment of \$200 or more, indicated at the end of the agreement, I understand that I will receive full download access to the selected SAWStudio product at the [www.sawstudio.com](http://www.sawstudio.com) web site, and that I will be sent a confirmation email including my total software purchase price, monthly payment agreement, and complete download instructions.

I understand that there may be (but generally not) a predetermined charge for future SAWStudio or SAWStudioLite updates, excluding maintenance releases which will be free of charge if I am at the current version. I am under no obligation to purchase any updates, and may choose to update at any time, paying the required fee for each version update I order.

I agree to make monthly installments toward the purchase of the selected SAWStudio product, in the amount indicated in the Monthly Payment Option section. I understand that payments will begin on the date this agreement is received, and will continue each month on the same date until the confirmed purchase price is paid in full. I understand that automatic monthly payment deductions will be made, as specified above, from the credit card number submitted with this order, and that after each monthly installment is paid, I will receive email confirmation. If I wish to adjust my monthly payments, I understand that I must email my request to [support@sawstudio.com](mailto:support@sawstudio.com), or notify RML Labs by fax at 702-257-1902.

I understand that I have a 30-Day option on my decision to purchase the selected SAWStudio product. If for any reason I'm not completely thrilled with the Software and I wish to cancel this agreement, I may do so within 30 days of my purchase date, with no questions asked, and will not be required to make further payments. I understand that in doing so, I forfeit my first payment and that there will be no refund or credit issued for any monies paid. I further understand that my download access to the selected SAWStudio product will be deactivated, and that I will be required to remove said Software from any and all machines on which it was installed and eliminate all backup copies of the Software in my possession. I understand that I must email my request to [support@sawstudio.com](mailto:support@sawstudio.com), or notify RML Labs by fax at 702-257-1902.

If at any time after the 30-Day option has expired, I cease making payments before completion of this agreement, I understand that this agreement is null and void, and I forfeit any and all monies paid toward the purchase of the Software and that no credit or refund will be issued for such. If a payment is not made due to a declined, invalid, or expired credit card, I understand that every effort will be made to contact me to make alternate payment arrangements before canceling this agreement.

If this agreement is canceled for any reason at any time, and I should choose to purchase the Software again at a later date, I will need to reapply for a new license and begin payments on the full applicable purchase price.
